Time Commitment

The expected time commitment is a minimum of 5 hours per month.

You are required to attend monthly virtual board meetings on the fourth Sunday of the month at 1:00 p.m. EST (these meetings typically last about two to three hours). You are also expected to serve on at least one of the board committees that meet monthly on weekday evenings (these meetings typically last about an hour).

Skills and Experience Sought

At this time, we are prioritizing individuals with expertise in:

 - a. This individual will chair our Human Resources Committee

2. Finance & Audit
 - a. This individual will serve as our Treasurer and chair our Finance & Audit Committee

3. Past Board Experience
 - a. This individual will serve as our Board President and be the board's link to the Executive Director.

As an organization serving the uOttawa student community, our board has quotas to ensure a diverse perspective on the board. Individuals applying must identify with one of the below:

Community Rep (01x individual sought)

Members of the Ottawa community at large and who have relevant professional experience.

Student Rep (03x individuals sought)

University of Ottawa students who have active valid student numbers for the duration of their term and are registered for at least one class at the University of Ottawa during their term.

These students must not have ever been employed by the FPS.

Staff Member Status (02x individuals sought)

A contributor who has assisted in the production of the Fulcrum, through a minimum of three (3) publications since the beginning of the Publishing Year in question. Unsolicited material, such as letters to the editor and classifieds, do not constitute a contribution.

University Rep (01x individual sought)

An individual who is employed by the University of Ottawa in some capacity throughout the duration of their term.

Essential Requirements

All members of the FPS Board of Directors must:

- be eighteen (18) or more years of age;
- not have an undischarged bankruptcy;
- not be an executive or full-time employee of UOSU or GSAED during their term;
- not be a member of the UOSU Board of Administration or GSAED Council; and
- not be an employee of the Fulcrum, own or invest in a company contracted by the Fulcrum
